Contract for Vendors

VCJC Indoor Bazaar/Carnival

December 8, 2019

The following is a contract between proposed vendors (hereinafter “vendors”) for the 15th Annual Indoor Bazaar/Carnival on December 8, 2019, and the Van Cortlandt Jewish Center (hereinafter “VCJC”)

The event will take place during the hours of 11am and 3pm. If reserved before the deadline, the cost of the first table provided by the VCJC is \$45, plus \$30 for each additional table provided by the VCJC. If a vendor is bringing his/her own table, the cost for space for the first table is \$35. Space for each additional table costs \$25. Any reservation requests made after the deadline shown below will incur a \$5 surcharge. The VCJC reserves sole authority to determine how many tables a vendor is using and how much must be paid to the VCJC.

Vendors will be given space, at the VCJC’s discretion, indoors at 3880 Sedgwick Ave. in the Bronx. Vendors are to arrive no earlier than 9:00am and no later than 10:30am for set up. The event is being held indoors, therefore there is no rain date or alternative accommodations. There is one floor allocated for this event – entrances are on Sedgwick Avenue and Stevenson Place (direct access – no stairs). Space is provided on a first paid and reserved, first served basis. **The VCJC is absolutely not responsible for any loss to vendors of any kind.**

No food can be sold by vendors unless Glatt Kosher and proper certification provided, subject to the advance approval of the VCJC. The VCJC reserves the right to ask that certain items not be sold by vendors. For example, but not exclusively, the VCJC prohibits the sale of any items of a sexual or profane nature and all violent toys.

Solely because this event is held in an Orthodox Synagogue religious icons not related to Judaism may be sold but not publicly displayed.

If a website address is provided, the VCJC agrees to provide a link in our on-line advertising of this event to the vendor’s website for the period of time from receipt of paid contract until December 8, 2019.
